GOMYLOCAL TERMS & CONDITIONS FOR INTERNET ADVERTISING AND MARKETING.

To simplify this document, we may refer to gomylocal, also known as gomylocal.com with the words "we" "us" "Our" & "its" This document will also refer to the customer or advertiser with the words "advertiser", "you" & "your"

Free listings which are updated will be given a login feature to access the dashboard for that account. As the administrator of a listed business you must agree to these terms.

Upon expiration of this 12 months term, the terms of this Agreement shall automatically renew for a "further 12 month Term" unless you or we notify the other of its intent not to renew. All services renewed will be subject to the current Terms and Conditions published at the start of that renewal term.

You agree that gomylocal will review all content of a listing for its suitability to our website before activation, you also accept that gomylocal reserves the right to refuse any advertisement that we regard as unacceptable or inappropriate for any reason.

Advertiser will be given, or will have created their own personal client login – which gives them the ability to change or update certain fields. gomylocal gives the Advertiser as much editorial freedom we see possible.

Advertiser warrants that they have the right to use all wording, and / or material submitted to gomylocal and such material does not violate any applicable law, copyright, regulation or ordinance.
